



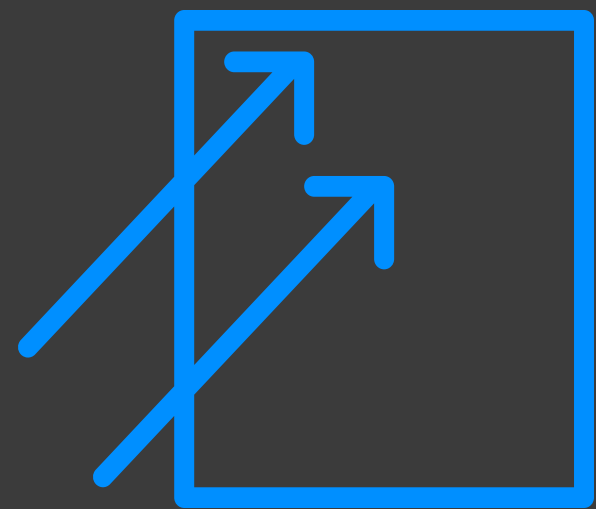

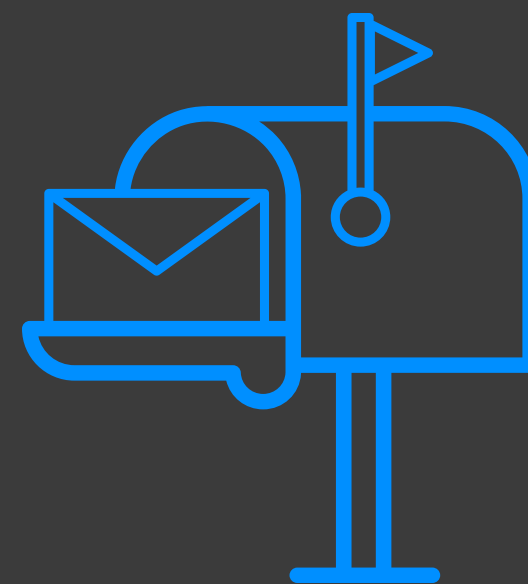

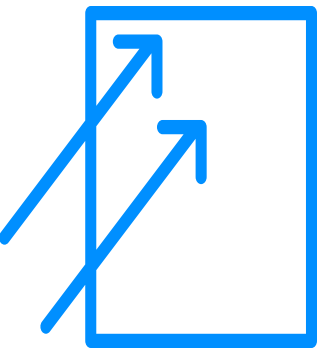

Frequently we are placed in a situation where a new client would like their employees to see their current elections when enrolling in their new benefits. This type of implementation has challenges and we are excited to announce this new feature, Simple Import. This feature is designed to display the employee's current coverage records (plan, covered members or coverage amount and cost) at the top of the screen when walking through their enrollment. No more importing current election, no more printing out paper forms to show their current coverage, no more building out current year plans to accommodate this view of current records. Yes, this means a clean slate method can be utilized AND employees will be able to see what they currently have.

If you have a new group onboarding and are interested in this implementation method, we will need just a few things to get this up and running. A spreadsheet including Employee SSN, Benefit Name, Plan Name, Coverage Amount or Covered Members, Cost. Using this information, we will be able to import the data from the spreadsheet into the benefit pages of a walkthrough and voilà, employees will be able to see their current records.

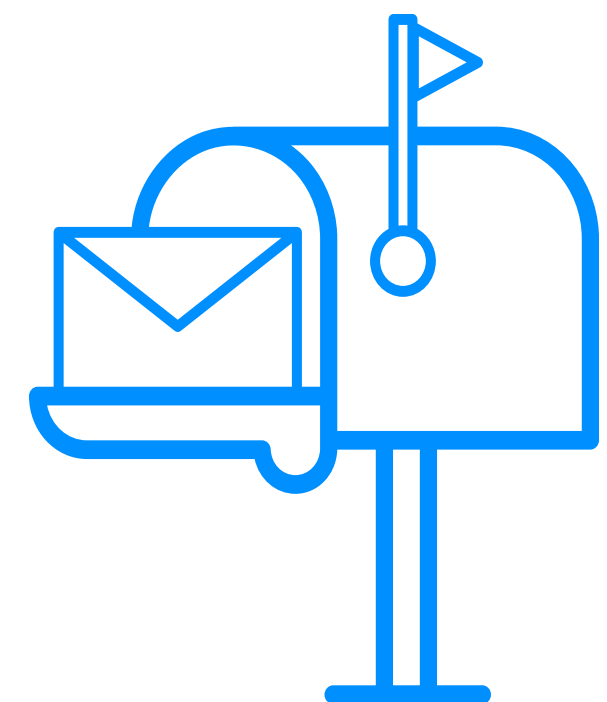
Because this information is in an open area (not tied to plan designs), this data is for display purposes. If your client is looking for current year management in **THEbenefitsHUB**, one of our takeover options may be a better fit for their needs.

Mailing and Residential Address

THE*benefits***HUB** now has the ability to accommodate both a Residential Address and a Mailing Address for an employee. As the residential address is entered, the mailing address will populate as the information is entered. If the addresses are different, you or the employee may un-check the box to allow editing to the mailing address. Both Quick Reports and Standards Reports have been updated to accommodate this field.

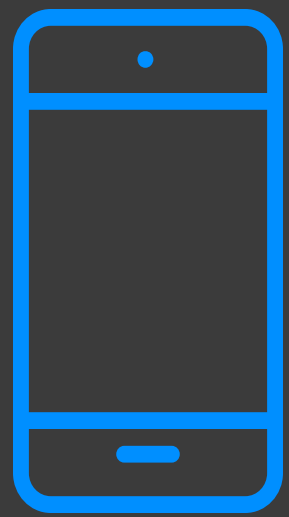


Broker Grouping

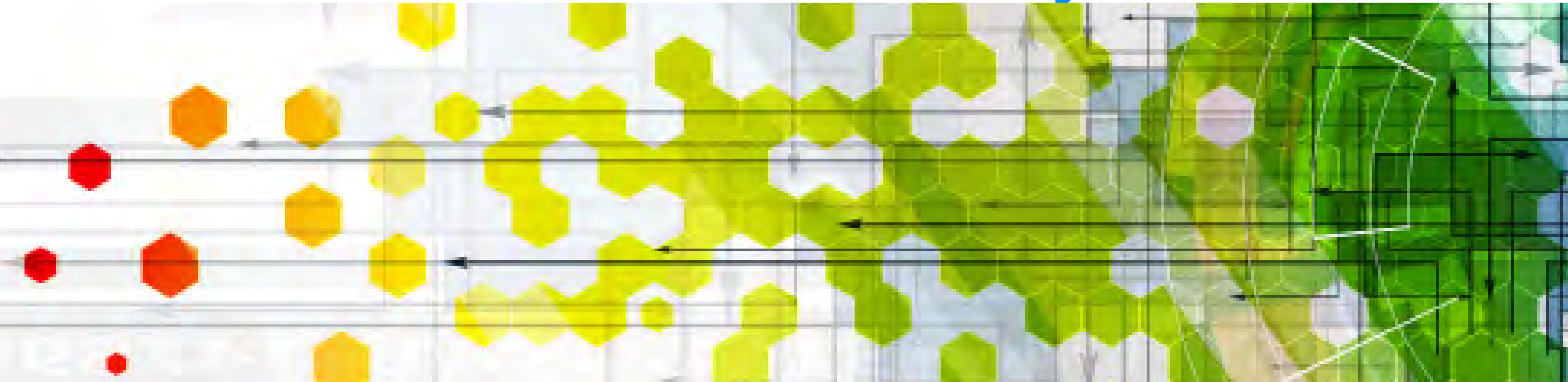
