Hello,

We have received the TRS EDI Schedule for the rest of the year through August 2020! Below, you will find all the different file types and dates combined onto one calendar for ease of use. On the day highlighted, the specified file type will begin running at 1 a.m. and continue into the morning until complete. Let's go over what each file type will contain:

- 2018-2019 Plan Year Files (Light Blue)
 - This is our current file we have been sending since September 1, 2018. This file will contain all elections and terminations for the 2018-2019 plan year.
- 2018-2019 Dual Year Files (Green)
 - This is the new dual year file we will be sending August through October. It will contain only changes from the 2018-2019 plan year.
- 2019-2020 Annual Enrollment Files (Orange)
 - This file will only be sent twice in August. It will contain the new plan year enrollments for 2019-2020 and the end of the previous plan year termination (i.e, all 8/31/2019 terminations that do not continue into the new 2019-2020 plan year).
- 2019-2020 Plan Year Files (Blue)
 - This will be the regular ongoing file that will be sent for the 2019-2020 plan year. It will contain all elections and terminations within the 2019-2020 plan year.

The discrepancy files should be ready to be picked up, reviewed, and worked two days after the EDI file send date (these dates are identified in light yellow on the calendar). It is very important to review and work these reports as soon as possible before the next file run to ensure your changes are processed within the guidelines of the 45-day processing window.

We hope this calendar is of use to you, but to assist you even further, we've also attached a document over how to read and breakout TRS files. This document is packed full of information that will help make translating these files into a readable format much easier for you. We are committed to helping you make TRS TRiumphS!!


